Transfer students with 50 or more transferable hours are required to take half the intensives requirements; two writing, one oral, and one using information technology. You must take these courses at ETSU as transfer credit does not satisfy the intensive requirements. In this articulation agreement, these courses are indicated by: Writing (W), Oral (O), and Using Information Technology (T). **NOTE: Intensive courses are built into ETSU program requirements. They are not additional hours.**
